PROCEDURES FOR REQUESTING AN ABSENTEE BALLOT

The Ute Mountain Ute Tribal Council and Election Committee, In Accordance with the Constitution and By-Laws as amended, including the Election Ordinance, hereby give; Notice of a Tribal Election for the purpose of electing (1) one Towaoc Tribal Council Representative.

(1) Council Delegate – Towaoc Council Member

Item 1: To elect for the three (3) year term, a qualified Tribal Member to fill the position now held by:

Item 2: (3) year term for Tribal Election

QUALIFICATION FOR VOTERS:

1. Enrolled members of the Ute Mountain Ute Tribe must be eighteen (18) years of age or older before October 09, 2020.
2. Enrolled members must be certified on the list of eligible voters maintained by Membership service department.

Please check the list of eligible voters which is posted at the Bureau of Indian Affairs building and Tribal Complex in Towaoc and WM Administration. Any corrections notify the Election Office at (970) 564-5635 Before August 10, 2020. Individuals will need to request for a Notarized form.


ABSENTEE BALLOTS:

Absentee Balloting for the 2020 Election will be allowed, for Non Resident Voters and Voters who will not be able to show up in person at the polling place on the day of election to cast their vote. You must request for an OFFICIAL Notarized absentee Ballot form in writing by September 11, 2020. Notice will be mailed to all eligible Non-Resident Members at the addressees maintained by the Tribal Finance Department's per capita database.
