INFORMATION FOR SEALING A CRIMINAL RECORD

- 1. Request the Clerk of Court print a copy of your criminal record. Please review this record carefully.
- 2. The Court of Indian Offenses does not have authority to seal any record in which you were CONVICTED of the charges against you. CONVICTED means that you pled "GUILTY", were found "GUILTY" or entered a plea of 'NO CONTEST." Look under the heading of "Finding" on your criminal history for each charge to determine the disposition of each case.
- 3. If the case was "DISMISSED" or "DEFERRED" you may petition the Court of Indian Offenses to seal the record as to that particular case. If your record contains both Convictions and DISMISSAL/DEFERREDS, you may petition for the sealing of part of your record.
- 4. If you choose to proceed with sealing your record
 - A. You must complete a Motion requesting the record be sealed.
 - B. Attach a copy of your criminal history with the Court of Indian Offenses to your affidavit.
 - C. Pay a \$50.00 filing fee via money order payable to the CFR Court, P.O. Box KK, Towaoc, CO 81334

** This does not pertain to Juvenile records. Juvenile records are automatically sealed upon the date the Juveniles turns the age of 18 years old.
