These are standard instructions are for informational purposes only and do not constitute legal advice about your case. If you choose to represent yourself, you are bound by the same rules and procedures as an attorney.

The filing fee is \$40.00 BUT THERE MAY BE ADDITIONAL FEES THAT YOU WILL BE REQUIRED TO PAY.
\*\*PLEASE NOTE: You should also expect to pay the following additional expenses:

These fees can range depending on the process server and attempts required. Expect approximately \$50.00

#### **HOW TO FILE YOUR CASE**

# Step 1: If the child is fourteen years of age or older, complete the required fingerprint-based criminal history check

Obtain your fingerprints from your local Sheriff's Office (or local law-enforcement office)

Law Enforcement will provide you with the finger print cards (you need 2).

#### **Towaoc Residents**

- → You are required submit your fingerprints to the Colorado Bureau of Investigations (CBI) and the Federal Bureau of Investigations (FBI)
- →You are responsible for mailing or hand-delivering the completed fingerprint cards to the CBI and the FBI.
- → The FBI requires an applicant information form to be submitted along with the fingerprint card. This form, along with additional information on FBI requests, can be obtained at the following link: <a href="https://www.fbi.gov/services/cjis/identity-history-summary-checks">https://www.fbi.gov/services/cjis/identity-history-summary-checks</a>
- → Mail the completed fingerprint card and applicant information form to the FBI at, Criminal Justice Information Services (CJIS) Division, Attn: SCU, Mod. D-2, 1000 Custer Hollow Road, Clarksburg, WV 26306 along with a certified check or money order. Do not fold the fingerprint card. You can also contact customer service at 304-625-5590.
- → Mail your completed CBI fingerprint card to the CBI at 690 Kipling, Denver, Colorado 80215 along with a money order. Do not fold the fingerprint card. You can also contact CBI at 303-239-4208 or <a href="https://www.colorado.gov/pacific/cbi/fees-and-forms">https://www.colorado.gov/pacific/cbi/fees-and-forms</a>.

#### White Mesa Residents

- → You are required to submit your fingerprints to the Utah Department of Public Safety Bureau of Criminal Identification (BCI) and the FBI.
- →You are responsible for mailing or hand-delivering the completed fingerprint cards to the BCI and the FBI.
- → The FBI requires an applicant information form to be submitted along with the fingerprint card. This form, along with additional information on FBI requests, can be obtained at the following link: <a href="https://www.fbi.gov/services/cjis/identity-history-summary-checks">https://www.fbi.gov/services/cjis/identity-history-summary-checks</a>
- → Mail the completed fingerprint card and applicant information form to the FBI at, Criminal Justice Information Services (CJIS) Division, Attn: SCU, Mod. D-2, 1000 Custer Hollow Road, Clarksburg, WV 26306 along with a certified check or money order. Do not fold the fingerprint card. You can also contact customer service at 304-625-5590.
- → The BCI requires an applicant information form to be submitted along with the fingerprint card. This form, along with additional information on BCI requests, can be obtained at the following link: https://bci.utah.gov/criminal-records/obtain-a-copy-of-your-own-criminal-history-record/
- → Mail your completed BCI fingerprint card and application to the BCI at 3888 West 5400 South, Taylorsville, Utah 84129 along with a payment. Do not fold the fingerprint card. You can also contact CBI at 801-965-4445.
- \*\*Important: Your criminal history checks should be completed within 90 days of filing the Petition. You should verify the length of time it will take the bureau of investigations to complete the background checks. The FBI will take longer to return the background checks than the state bureaus. You should mail the FBI fingerprints earlier so that you get both checks back about the same time.

## Step 2: Complete Petition for a Change of Name (Minor)

### Step 3: You are Ready to File your Case with the Court.

Provide the Court with the Petition and (if fourteen years of age or older) FBI and CBI or FBI and BCI fingerprint-based criminal history record checks. Make sure that the fingerprint-based criminal history record checks are conducted within 90 days prior to the filing of the Petition.

## Step 4: Provide notice to the non-custodial parent(s)

After the court reviews your Petition, you will be provided with a notice to the non-custodial parent(s) and instructions for personal service. You will also be provided with a blank consent form. If the non-custodial parent is in agreement with the name change, he or she can waive personal service and complete the consent form (sign it in front of a notary public or the court clerk) and file with the court.

#### Step 5: Court Hearing

If the noncustodial parent does not consent to the name change, a hearing will be scheduled after personal service is completed.

#### Step 6: Publish proposed name change

If the court approves the name change or consent of the noncustodial parent is filed, you will receive an order for publication from the Court. The change of name must be published at least three times within 21 days from the date of the publication order in a newspaper; unless you are excused from publication because you are the victim of a crime of domestic violence, victim of child abuse.

#### COURT HEARING

Once you submit proof of publication to the Court a final hearing will be scheduled. The court will issue a final decree of name change at the hearing.
